OBJECTIVES OF THE STUDY:

A. GENERAL

This study aimed to analyze the administration of barangay justice system.

B. SPECIFIC

RECOMMENDATIONS:

- 1. The barangay captain must continue its role in the efficient administration of barangay justice in order to maintain peace and order in their respective barangays.
- 2. The students should conduct similar studies in order to shed light on some questions the authors had not been able to give answers.
- 3. The government should give importance to the role of barangay officials in administering justice that helps in the speedy and efficient disposition of cases.
- 4. The government should also, support the programs conducted by the barangays, especially those related to the administarion of peace and order in their community.
- 5. Barangay officials must encourage its members to extend their cooperation and listen to the advises given to them that will help in the development of their communities.
