Objectives of the Study:

#### A. General

The study aimed to analyze the programs of Governor Erineo S. Maliksi and its socio-economic effects in the development of Cavite (2001-2004)

### **B.** Specific

The study aimed to answer the following questions:

- 1. What are the programs of Governor Erineo S. Maliksi from 2001-2004 in the following sectors:
  - 1.1. Agriculture?
  - 1.2. Infrastructure?
  - 1.3. Employment?



- Among the programs, which made the biggest contribution to the socio-2. economic development of Cavite?
- What are the future plans of Governor Maliksi on the continuous development 3. of Cavite through the implementation of his programs?

### Methodology

The descriptive – documentary analysis was used by the researchers in order to determine the different available documents, socio – economic profile, accomplishment reports and records of the Province of Cavite. Interpretation and review of all data and documents gathered were also done.

## **Major Findings:**

The programs of the Governor Erineo Maliksi were conceptualized to address 1. the different social needs of the Caviteños, such as unemployment, lack of adequate facilities and alternative jobs for those who did not finish or were unable to study. The programs are aimed to give the province and its people development not only in the social aspects but the economic status as well. The programs were created for a specific sector to solve a specific problem, while other programs are focused on the strong points of Cavite for the further development of the province. Most of the programs implemented by the Governor were more on the agricultural sector since it is the forte of the province where most of the products of the province come from, but that doesn't mean that the use of new technology for industrialization is not prioritized.



- Pangisdaan Aquaculture Livelihood Program provided essential information to fishermen and fisher folks resulting to the increase on the production of marine resources. Tilapia, bangus, oyster and mussels are the most productive and profitable marine resources in Cavite. Through improved road networks, Cavite became a preferred destination of both local and foreign investors which paved way for its rapid urbanization. Also with the increase of the entry and exit points it made the province more accessible to different industrial estates specializing in manufacturing, sewing crafts, and food processing. Through job fairs, it gave the Caviteños a chance in finding a job within the vicinity of the province.
- 3. The future programs of Governor Maliksi are designed for the continuous improvement of Cavite. It showed that his administration is focused in gearing Cavite to be a competitive Agro-Industrial province. With his programs, he is aiming to make Cavite as one of the most developed provinces of the Philippines, wherein the people have an appropriate standard of living and the security of everybody is kept.

#### **Conclusions**

Based on the findings of the study, the researchers concluded the following.

1. Governor Maliksi provided different programs to answer the different needs of the Caviteños, thus aiming for the socio-economic development of Cavite. His



programs are designed for the improvement of the standard of living of every people. Those programs are planned for the development of Cavite and its citizens.

- 2. The programs of Governor Maliksi helped increase the rate of business opportunities and new technologies coming in, which resulted to the continuous development in the province. Social infrastructure helped in the molding and the transformation of Caviteños and helped provide the delivery of basic services to the people as well as the emergence of new industrial estates in the province. Job fairs and trade markets although not new still helped unemployed Caviteños to acquire jobs and showcase local products for the improvement and expansion of the economic industry in Cavite. The programs in aquaculture and advanced farming helped a lot in the advancement as an Agricultural-Industrial Province.
- 3. The future programs of Governor Maliksi are aimed to sustain the development of Cavite. It is also planned for the further improvement of the province.

#### **Recommendations:**

1. The Office of the Governor should take much consideration in the number of the unemployed in Cavite. More facilities for the development of practical skills and training should be established throughout the province. The provincial government should also improve the processing of local products such as coffee, pineapple, banana, and corn rather than selling them as mere fruits or raw materials. The local



government should focus more on how to ease the presence of traffic congestion and pollution on developed municipalities and cities.

- 2. The Maliksi Administration should consider measures in sustaining the different socio-economic programs which started for promotion of the development of the province even after the end of its term.
- 3. The provincial government goals should be aimed in uplifting the living condition of the Caviteños, through effective programs implemented. It should also consider programs that will answer the basic problems of the people like food, clothing, job opportunities and adequate facilities. It should also promote more chances for people participation to attain sustainable development.
