SCOPE AND DELIMITATION

This study focused on the comparison between Presidential Anti-Organized Crime Task Force (PAOCTF) and Police Anti-Crime Emergency Response (PACER) as crime busters. It included the solved and unsolved cases by PAOCTF and PACER. It gives information's regarding PAOCTF and PACER on how they helped the country reduce crime.

FINDINGS

1. The two task force agencies, the Presidential Anti-Organized Crime Task Force (PAOCTF) and Police Anti-Crime and Emergency



Response (PACER), were created through the office of the president to solve crimes.

- 2. PAOCTF and PACER are both under the Philippine National Police (PNP).
- 3. The researchers found out that the PAOCTF is broader in scope rather than PACER.
- 4. It is clear that PAOCTF is handling more crimes in the country, while PACER is more on solving Kidnapping-For-Ransom (KFR) cases.

CONCLUSION

The researchers conclude that:

- 1. Presidential Anti- Organized Crime Task Force (PAOCTF) was a single task force of the Philippine National Police (PNP) during the time of Estrada, while today Police Anti Crime Emergency Response (PACER) is just one of the agencies of the Philippine National Police (PNP).
- 2. Today people are being confused with the programs and agencies created by the present administration.
- 3. Redundancy of the purposes of agencies in solving crimes today is being practiced by the present administration.



4. With this redundancy, the budget of the PNP will be consumed by this agency, so it is budget consuming.

RECOMMENDATIONS

The researchers in their study of comparative analysis of the Presidential Anti - Organized Crime Task Force (P.A.O.C.T.F.) and of the Police Anti – Crime Task Force (P.A.C.E.R.) recommend that:

- 1. The Arroyo administration should have only one task force in solving crimes, just like the Estrada's administration. In having just one agency, the budget can be used for other programs of the government.
- 2. There should be a speedy trial for the arrested suspects.
- 3. There should be cooperation in the branches and agencies of the government to easily solve crimes.
