ABSTRACT

Alabang Country Club Inc. is a non-profit corporation established in 1981 through the ownership of Proprietary and Corporate Shares. The Club was formed primarily to provide a wholesome venue for sports and recreational activities while simultaneously providing quality service worthy of its members. Alabang Country Club Inc. was a project developed by the Ayala Corporation under the direction of Don Enrique and Don Jaime Zobel de Ayala. Started on June 18, 1979, ACCI was completed and opened to its members on January 6, 1981.

By gathering sufficient information through research, interview and company visitations, the proponents were able to develop a system that will help Alabang Country Club Inc. in the reservation and billing process. . The requirements and specifications stated by the company are also taken into consideration.

The developed system helped ACCI to resolve the issues dealing with data inconsistencies and record-keeping which was present in the existing system. It also includes the process of checking available dates and reservation for golf and sports amenities and the process of initial reservations for tournament and event reservations. To alert the system users regarding the status of their reservations, the system is also capable of sending email alerts to the users. The system also computes the Statement of Accounts of the users which they can view when they login to the page.
